Constitution 2.4v

- c. the Committee has approved the application. The Committee reserves the right to refuse membership provided they have sufficient reason to do so.

Liability is limited to £1, being the amount that each member undertakes to contribute to the assets of the company in the event of its being wound up while he is a member or within one year after he ceased to be a member.

Current Rule

The Membership Secretary shall maintain an up to date list of members of all categories. He shall receive applications for membership and process these as appropriate. He shall issue membership renewal application forms by whatever means appropriate including online, four weeks prior to the date on which subscriptions become due. With these he shall issue application forms for moorings, winter storage and for space in the boathouse and pound. Upon return of these forms, he shall **issue membership cards to members, update the list of members and pass the subscriptions and fees to the Treasurer**. He shall also issue Club security keys. Revised lists of members shall be distributed as follows: one to each of the Officers and others as deemed necessary by the Committee.

Proposed revised Rule

The Membership Secretary shall maintain an up-to-date list of members of all categories. He shall receive applications for membership and process these as appropriate. He shall issue membership renewal application forms by whatever means appropriate including online, *at least* four weeks prior to the date on which subscriptions become due. With these he shall issue application forms for moorings, winter storage and for space in the boathouse and pound. Upon return of these forms, , *he will arrange for fees to be collected and update the membership records. For new members arrangements will be made for the issue of Club security keys*. Revised lists of members shall be distributed as follows: one to each of the Officers and others as deemed necessary by the Committee.

The booklet shall be distributed so as to arrive with members no later than two weeks before an AGM."

Propose to amend as follows:

"The Board will prepare an Annual Report to include reports from Flag Officers and Ordinary Board Members, the annual statement of accounts and any other relevant or useful information. The report shall be distributed by email so as to arrive with members no later than two weeks before the AGM. Paper copies will be posted to those few who do not use email."

Justification: Printing and posting hard copy reports would cost several hundred pounds. The recently introduced email newsletter reaches nearly all members at no cost. Very few members collected the paper report prepared last year.
